 1 year: expires 3/31/17, rabies vaccination must be current on purchase date.  
 2 year: expires 3/31/18, rabies vaccination must expire after 4/1/18.  
 3 year: expires 3/31/19, rabies vaccination must expire after 4/1/19.

**License Your Pet Online:**  Go to [www.petdata.com](http://www.petdata.com) and enter your zip code.  Under License Now, click "Online." Documentation may be uploaded or submitted later by fax, mail or email. Pay with a major credit card. A convenience fee will apply per transaction. Multiple pets can be licensed in one transaction. Seniors may not apply online.

**License Your Pet by Mail:**  Complete this application,  **Enclose a copy of your pet's current rabies vaccination certificate**,  Enclose proof of spay/neuter if it is not indicated on the rabies certificate,  If senior citizen (60+), enclose proof of age, such as a driver's license. You may remove the DL# before submitting,  Make your check or money order payable to City of Sterling Heights *(please do not send cash)*  **Mail to:** Sterling Heights Dog Licensing, c/o PetData, PO Box 141929, Irving TX 75014-1929.
